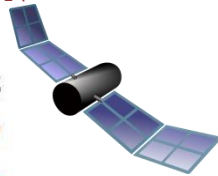

## **NETWORK PARTICIPATION AGREEMENT**

This is your program distribution agreement. It makes your show available to 5500 radio stations on their XDS Digital Satellite receivers. This agreement does not guarantee that other stations will automatically broadcast your program. Instead, it guarantees satellite delivery of your show to thousands of stations that may choose to broadcast it.

For purposes of this satellite distribution and syndication agreement, **The AM First Radio Network**, (not KCAA) will be presented to potential affiliates as your show's production and distribution service.

**Broadcast Management Services, Inc.**, the licensee of KCAA Radio, has signed an agreement with **Global American Broadcasting Company, (The GAB Radio Network)**, to place your show on the WestwoodOne Satellite Service. GAB will provide satellite delivery of participating KCAA radio programs which broadcast on KCAA AM-FM Radio.

The cost to broadcast your live show on the WWO satellite is \$100. The cost to broadcast pre recorded shows is also \$100. The cost of broadcasting live shows and storing them on an FTP server for affiliates to download and broadcast is \$125. The ending date of this agreement will mirror the ending date of our current agreement to broadcast your show.

Your show will be fed to the GAB facility in Chicago by a dedicated Comrex Access digital encoder located in the KCAA studios. The GAB engineer will uplink your show to the WWO satellite facilities for either live or scheduled rebroadcast. This makes your program available to all radio stations using WWO XDS Satellite receivers.

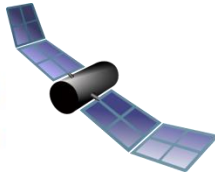
Stations that choose to become your affiliate will program their XDS receiver to receive your show and, either play it back live at the feed time or schedule their equipment to delay-broadcast your show at a time their agreement with you specifies.

The XDS receiver utilizes a "store-forward" function that allows it to capture any show fed through the satellite system to be played back whenever scheduled locally. Pre-recorded shows are usually downloaded from the satellite between 2 and 5 a.m. for replay by the affiliate station at a later date and time. Live shows will air at the same time they are produced in the KCAA studios.
