RADIO STATION AFFILIATE AGREEMENT

Please complete one agreement for each frequency.

The AM FIRST RADIO NETWORK is a service of Broadcast Management Services, Inc., a Texas Corporation and the licensee of KCAA Radio, Loma Linda, California, hereinafter referred to as "AMFIRST" with studios located at 254 Carousel Mall in San Bernardino, California 92401.

(1) AM FIRST will make all of the programs selected in the attached "Program List," available to _____ (radio station) on a market exclusive basis, unless this agreement is otherwise amended. The affiliated Radio Station agrees to air this programming on the dates and times specified for each individual program shown on the "Program List."

(2) The affiliated Radio Station will provide a signed and dated copy of this affiliate agreement to AM FIRST before broadcasting any program.

(3) The affiliated Radio Station shall not defame AM FIRST or other broadcasters who air shows on The AM FIRST RADIO NETWORK.

(4) The affiliated Radio Station shall receive programming from the distribution systems listed below. (SELECT one or more):

Live via XDS Satellite receiver _____

Live via AM FIRST Internet Streaming _____

Delayed from either the XDS or Download (please circle one)

Broadcaster will notify AM FIRST of changes in Program broadcast time.

(6) This agreement applies to the following AM/FM radio station:

(7) AM FIRST may request the broadcaster to furnish a monthly affidavit of program broadcast times with notations of any preemptions or rescheduling from normal broadcast time.

(8) The affiliated Radio Station agrees to broadcast the program in its entirety, including network commercials specified on the attached Program Clock.

(9) AM FIRST guarantees market exclusivity for the program(s) on the "Program List."

(10) This agreement shall be in effect indefinitely from the date of signing below. AM FIRST or the Radio Station may terminate this agreement on 30 days written notice tendered by either party to the other.

(11) If AM FIRST or the Radio Station fails to comply with any provisions set forth in this agreement or is unable to cure defects in their performance hereunder following written notification of such defect, the injured party may withdraw from this agreement by providing five (5) days notice to the other party of their intent to end the relationship.

(12) The terms above represent the complete terms of agreement between AM FIRST and the Radio Station, subject only to the attachments and amendments otherwise described.
